# Atlantic Packaging Wellness Incentive Program 2019/2020



### Earning Points Towards Your Reward

### 1. Completion of a Biometric Screening (10 points)

\*Points will be awarded automatically to those that participated in the onsite events in Fall 2019 as well as those that complete their screening at the Health Center in Tabor City. If you complete your screening with your PCP, upload your Physician Screening form to <a href="https://atlanticpkg.uswellness.com/">https://atlanticpkg.uswellness.com/</a> to receive points.

#### 2. Completion of a Comprehensive Health Review (10 points)

\*This is a visit to review the results of your biometric screen and Health History and Risk Assessment (HHRA) questionnaire for a thorough assessment of your health and any possible risk factors. Please be sure to fill out your HHRA on line and have your biometrics performed prior to your visit. You can schedule this appointment by logging into the Marathon eHealth Portal, by contacting your Health Coach or if you are located in Tabor City, by calling the Health Center.

#### 3. Health History and Risk Assessment or HRA Update (10 points)

\* Click on the questionnaires tab to complete your Questionnaire with incentive icon. () If you completed the questionnaire in Fall 2019, points will be awarded automatically. Questionnaires completed from 11/6/2019-8/31/2020, points will be automated as well.
